**DISMISSAL ROLL BEFORE HIS LORDSHIP SAKOANE CJ TO BE HELD IN
COURT ONE (1) ON THE 16TH AUGUST, 2023 AT 09:30 AM**

- [1] Notice is hereby issued to all practitioners that all the cases listed hereunder have not been prosecuted despite being filed in the past six (6) months or more. Neither has there been steps taken by the parties towards ensuring that the cases are either prosecuted or dismissed for want of prosecution.
- [2] The Chief Justice has directed that notice be served on all the listed cases and/ or counter-claims if any, and that they be put on a motion roll for purposes of considering their dismissal for want of prosecution on the abovementioned date/s.
- [3] All parties and their legal representatives are directed to appear on the said date to show cause why their respective cases shall not be dismissed for want of prosecution.
- [4] In the event that a case is not liable for dismissal for want of prosecution, the parties must come prepared for the court's imposition of conditions for future conduct of the proceedings for the expeditious disposal of the cases.
- [5] Legal practitioners are advised to ensure that their files are court-ready (i.e. *checklist, index, pagination, bound* etc.). Failure to appear or ensure that files are court-ready will result in the automatic dismissal of cases.
